- 1. Opening Remarks
 - -May 24, 2023 General Membership Minute Approval
 - -Motion Berks Catholic, Second Twin Valley unanimously approved.
- 2. District III/PIAA Report & Update
 - -No new update, next meeting December 9th
- 3. Executive Director and Board of Directors Reports
 - -Treasurer Report & Approval
 - -Checking Account \$152,973.17
 - -Investment Account \$31,318.95
 - -Motion Dave Cummings, Second Governor Mifflin unanimously approved.
 - -Fall Playoff Financial Report
 - -Overall Fall revenue was good when things were averaged out between sports (some higher and some on the lower side).
 - -Fall Sport Chair Reports
 - -Volleyball some discussion on changing playoff dates and home court advantage. Nothing new to propose at this time.
 - -Cross Country question on if teams could enter additional runners if other teams do not have 7 runners some discussion on adding a JV race. Coaches are in favor of counting league meets as forfeits if a team does not have 5 runners for purposes of league records.
 - -Tennis no changes requested
 - -Soccer no changes requested some discussion on boys' side about using Alvernia for the championship (not practical for seating), discussion on girls' side to clarify ball runners (should be 2 for each team on same side as team bench).
 - -Golf some discussion on changing the number of participants but did not have 2/3 majority to move a change forward.

-Field Hockey – no changes requested – will update playoff and allstar formats for next cycle when there are only 2 divisions.

- 4. Old Business, New Business & Discussion Items
 - 4.1 LL Football 2024-2026
 - -Discussion on the schedule requiring Thursday/Saturday games next cycle.
 - -Initial approval of the combined football league was for 4 years, so conversation needs to start with commitment past the 2025 season. Kerry will discuss that with Todd Reitnouer when they meet next.
 - 4.2 BCIAA Wrestling Tournament (Girls & ATC Coverage)
 - -Kerry is still working with St. Lukes on what the ATC coverage will look like.
 - -Still working on how the girls will be incorporated into the individual championships.
 - 4.3 Arbiter Pay Official Notification (end of agenda)
 - -All officials have been notified on Arbiter announcements of the need to have an Arbiter Pay account for the 24-25 school year.
 - 4.4 Media Coverage of Conference Championship Events Blue Book Page 29 (Action Item 5.1).
 - l. Photographers wishing to take pictures on the field or court must show proof of liability insurance to either the contest game manager or the BCIAA Executive Director. Any photographer/s who are not able to provide proof of liability insurance will only be permitted to take pictures from the stands and will not be granted access to the playing surface.
 - 4.5 Gold Leaf Criteria Blue Book Pages 17-18 (Action Item 5.2) The Conference oversees the Gold Leaf awards, which recognize individuals who have served the Conference for at least twenty (20) years. Individuals for consideration must have been a coach, administrator or athletic department employee. Individuals who meet the criteria for inclusion will be inducted into the Gold Leaf during an induction ceremony organized and run by the Conference under the direction of the Executive Director. BCIAA Member Schools must submit all nominees for induction to the Executive Director via a Google Form that requires all inductees to be classified as either a coach, administrator or athletic department employee. Final approval for Gold Leaf induction will come from the BCIAA Executive Director and/or the Board of Directors. Upon induction, members will receive a gold metallic card which allows the member to attend all Conference events (including playoff games) for the rest of their lives.
 - 4.6 BCIAA League Scheduler Stipend (Action Item 5.3)
 - -Stipend of \$2500 to include all league schedule preparation/parameters and entry into League Central, and include any potential corrections/changes/updates to the league schedules.
 - 4.7 BCIAA Executive Director Stipend (Action Item 5.4)

- -Last increase to the Executive Director stipend was in 2019-2020 -Proposal for the 2023-2024 Executive Director stipend to be increased to \$25,000, subject to a 3% annual raise over the course of the current official's stipend approved fees (through 2026-2027). 4.8 Golf Preferred Lies Blue Book Page 45 addition (Action Item 5.5)
- For all matches, including the Championships, preferred lies will be played in the Fairways. The ball may be marked, lifted, cleaned, and placed within 1 club length, no closer to the hole. If adverse weather affects course conditions a decision will be made in consultation with the course pro shop.

Arbiter 2024-2025 Ref Pay Announcement:

All BCIAA member schools will be utilizing ArbiterPay starting with the 2024/2025 School Year. All Officials working Sports contests for BCIAA member schools will need to sign up for an ArbiterPay account and link that to your ArbiterSports account so that schools can quickly and easily release your payments. You must have an active ArbiterPay account that accepts payments to work sports for BCIAA member schools starting with the 2024/2025 school season. When you accept your assignments on Arbiter Sports you confirm that your Arbiter Pay account is active and accepting

payments from schools where you have assignments. Failure to have an active Arbiter pay account will prohibit schools from sending payments until your Arbiter pay account is in an active status and accepting payments. Officials have the option with ArbiterPay to have funds directly deposited (self-initiated to make the transfer from your ArbiterPay account) to a bank account (must provide bank account information) or you can select alternatives if you do not wish to provide your bank account information for direct deposit. Each school district using ArbiterPay will be covering the fee per/assignment to use this service, but any additional fees incurred by officials for selecting payment options other than self- initiated direct deposit will be responsible to cover those additional fees for those selected services.
